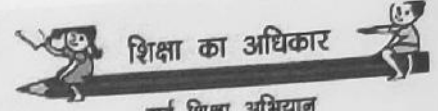

12. Technical Bid will be accompanied with cost of document, Earnest money, upto date Registration certificate, Sales Tax Clearance, GST Registration, Income Tax Clearance certificate, Character Certificate issued by DM/DC/SP. In absence of above required document the tender will be rejected. The financial bid will contain Price Bid of the work as mentioned in Para 7 column 4. The Financial Bid will be opened only after technical evaluation has been Completed.
13. District Education Officer-cum-District Programme Officer, Jharkhand Education Project reserves the right to accept or reject the tender received without assigning any reason thereof.
14. The successful tenderer shall have to deposit security deposit @ 5% of estimated cost which will include the amount of earnest money deposited as mentioned in Para 7 column 4. The tenderer will have to also deposit Security money @5% from each running account Bill.
15. The Earnest money of the successful tenderer will be forfeited in case the tenderer decline to sign the agreement within 7 days on being called upon to do so after approval of competent authority.
16. Notice inviting tender with general rules and special conditions will form part of contract documents.
17. Before submitting tender papers tenderer should be acquainted with site conditions and availability of construction materials at the site and get themselves fully satisfied with site condition.
18. Subletting of work will not be allowed and if found so, agreement will be cancelled.
19. The tenderer should fill up the check list and should also mention the page no of documents where the certificate is placed, in absence of this the tender may be rejected.
20. Conditional tender will be outright rejected.
21. Clause 23 of F2 agreement is deleted.
22. No claim will be entertained for delay in payment against work done. Payment will be done as per availability of fund.

CHAPTER-II
GENERAL RULES

(a) Sealed tenders in shape of technical and financial bid will be received from eligible registered contractors only of appropriate category by the District Education Officer cum District Programme Officer, JEP, Ranchi or his authorized person for the works mentioned in the table of NIT. The estimated cost may vary as per approved bill of quantity.

(b) Tender paper can be downloaded from (a) www.dseranchi.com or obtained from the office of Jharkhand Education Project, MS BMP Doranda Campus, Near High Court, Ranchi-834002 by those contractors/builders who are registered in appropriate category with building construction department Government of Jharkhand / C P W D/ State Govt. undertaking. The application for issue of Tender Paper from JEPC, Ranchi should enclose the photocopy of their registration.

- 2.2 The Tender Documents should be submitted in a sealed envelope on the date as specified in para 4 of NIT at JEP, Ranchi. The tenders will be opened by District Education Officer cum District Programme Officer, JEP, Ranchi or his authorized representative person on the date and time mentioned above. The tenderers or their authorised agents who-so-ever desire may remain present at the time of opening of the tender.
- 2.3 The Items of works, plans, specifications, or any other information in connection with the work can be seen in the office of JEP, MS BMP Doranda Campus, Near High Court, Ranchi-834002 on any working day during office hour.
- 2.4 Tender Documents download from website must accompany with Bank Draft of requisite amount and should be submitted with technical bid. The requisite amount is mentioned against each work in NIT and it is Non refundable. The bank draft should be in favour of DEO-CUM-DPO, Jharkhand Education Project, Ranchi, payable at Ranchi. Tenders without requisite amount of Cost of Document in the required form shall be rejected.
- 2.5 The tenderers are required to deposit Earnest Money as mentioned against each work. This may be in the form of Bank Guarantee of Nationalized bank issued in favour of DEO-CUM-DPO, Jharkhand Education Project, Ranchi or NSC (8th issue) or pass book of Post Office or Term deposit pledged in favour of DEO-CUM-DPO, Jharkhand Education Project, Ranchi. Tenders without requisite amount of Earnest Money in the required form shall be rejected.
- 2.6 The tenderers should quote their rate on over all items (not item wise) in percentage below or at par or above (both in figures & words) on amount of approved bill of Quantity.
- 2.7 In case of overall rate Quoted by the tender is less by 10% from the approved BOQ rates; the tender will be treated as unworkable and will be rejected abinitio.
- 2.8 It will be obligatory for the tenderer to keep his offer open for acceptance for a period of 90 days from the opening date of the tender.
- 2.9 Sales Tax Clearance certificate, PAN no., Labour License and character certificate issued by D.M./D.C/S.P. shall be submitted by the tenderer. The tenderer will have to submit GST Registration

detail with clearance certificate. All the certificates should be upto-date. The tender in absence of these documents will be rejected.

- 2.10 The DEO-CUM-DPO, Jharkhand Education Project, Ranchi reserves the right to accept or reject any or all of the tenders received without assigning any reason thereof.
- 2.11 If work is awarded to successful tenderers, the amount of Earnest Money will be transferred towards the initial security deposit, which will be 5% of the value of the tendered cost. The initial security deposit will include the amount of earnest money already deposited at the time of submission of tender. The total security deposit will be 10% of which remaining 5% shall be deducted from each running bill.
- 2.12 The earnest money of the successful tenderers will be forfeited in case tenderer declines to execute the agreement or fails to deposit security money as mentioned in Notice Inviting Tender within 7 days of being called upon to do so after the approval of his tender by the Competent Authority.
- 2.13 **The N.I.T. with general rules and special conditions will be part of contract document.**
- 2.14 Conditional tender will not be acceptable and will liable to be reject. The complete tender document with all its enclosures shall be enclosed in sealed envelope and delivered to the State Project Director, J.E.P.C, Ranchi so as to reach on or before the date and time as mentioned in N.I.T. The tender documents received after the date and time as stipulated in N.I.T. shall be rejected.
- 2.15 The tenderer should mention a list of all documents enclosed with the tender in his forwarding letter.
- 2.16 The tender shall contain the full name, address of office and residence and place of business of person or persons filling the tender. In case of any change in address, it must be informed to the State Project Director by registered post. They should give their full detail such as Tel No., Mobile No., e-mail id, Fax, etc.
- 2.17 All pages of tender document including general rules and special conditions must have Signature at the lower left hand corner and wherever required in the tender papers by the tenderer or a person holding power of attorney authorized to sign on behalf of the partners before submission of the tender.
- 2.18 In the event of the tender being submitted by a firm it must be signed by each partner or authorized person by the firm. The power of attorney authorizing him to do so must be enclosed with the tender.
- 2.19 The rates quoted by the tenderer shall be inclusive of income tax, sales tax, Central tax or any other taxes applicable at that time.
- 2.20 The tenderer shall be presumed to have carefully examined the conditions of the contract and specification of the work. The tenderer will also be deemed to have inspected the work site and have satisfied herself/himself/themselves independently as to the nature and extent of all works, e.g. availability of land, road, means of accommodation that may be required for temporary purpose in connection with the contract work, availability of construction materials, location of work site including its climate and other geological characteristics, availability of skilled, semi skilled and un-skilled labourers. The consequence of the lack of necessary knowledge will be at the risk and to cost of tenderer.

- 2.21 Specification as mentioned in Schedule of rate for each item shall be followed during execution of work. Item of works, for which specification in schedule of rate is not available specification provided by engineer in charge will be followed.
- 2.22 The tenderer shall submit a detailed construction programme of the work immediately after award of the work which shall be a part of the agreement. The programme shall be in such form and details as to properly show the sequence of operation and period of time required for completion of work under each item of work within the frame work of his construction programme.
- 2.23 The contractor shall make necessary arrangement for the security of his staff, materials and labourers, service road etc. at site at his own cost. They will have to make arrangement entirely at their own cost for water supply needed for the construction work and he has to make arrangement entirely at his own cost for obtaining supply of Electrical Energy.
- 2.24 All labourers are to be paid as per minimum wages act in force and as revised from time to time during the construction of work. The successful tenderers shall be bound to adhere and follow rigidly the prevailing labour laws or which may come in force even after execution of the contract agreement with regard to the payment to workmen or their wages, compensation for incurring injuries or meeting death while engaged in actual work. Failure on the part of tenderer to fulfill these statutory requirements will empower the DEO-CUM-DPO, Jharkhand Education Project, Ranchi to rescind the agreement and make good from the bills and other dues of the Tenderers. DEO-CUM-DPO, Jharkhand Education Project, Ranchi may enforce other penal action also against the tenderer.
- 2.25 The contractor will provide labour huts, drinking water and medical facilities to labourers at site and keep the site clean at his own cost.
- 2.26 After issue of written order to the selected tenderer from the State Project Director they have to deposit the balance amount of initial security deposit (ISD) within the specified period of **Seven Days** and then enter into agreement. Agreement will be executed on F2 - form prescribed for public works department.
- 2.27 In case of delay in completing the work the penalty shall be imposed as per PWD Rules.
- 2.28 Any letter issued to the contractor and posted at the address given in the tender document shall be deemed as delivered to the contractor and JEP will not take any responsibility of non deliverance, whatever the reason may be.
- 2.29 Any false representation will lead to disqualification of the contract and legal action will be taken
- 2.30 Completion period of the work will start from the date of issue of work order. The work must be completed in all respect within or on stipulated time.
- 2.31 Financial bid of tenderer who qualifies in technical bid will only be opened. Date & time will be communicated to qualified bidders separately.

CHAPTER-III
SPECIAL CONDITIONS

- 3.1 A site order book issued by the E/I. shall be kept at the site office and . All entries there in shall be signed by the Engineers and the contractor or his authorized representative. The site order book shall not be removed from the work site except with written permission of E./I. The contractor or his authorized representative shall be bound to take note of all instructions and directions meant for the contractor as entered in the site order book without having to be called on separately to note them.
- 3.2 The contractor should always remain available on the work site, but when it is not possible for him, he must appoint a representative who would be dully authorized by the contractor to receive and carry out instruction of JEP. A copy of authorization letter should be submitted to E/I.
- 3.3 If the royalty clearance certificate for materials used in work is not produced with the bill, royalty will be deducted by the council from the bill of the contractor at the rate prevailing at the time of execution of work to which the bill relates.
- 3.4 All the materials to be used in construction should be of standard specification and conform to Indian Standard including cement of PSC/PPC/33grade/43grade/53grade/National level companies product. Such as Lafarge/ ACC/ L&T etc (Mini Cement Plan's product are not allowed)and HYSD bars conforming IS 1786 of grade FE 415, FE 500. (Product of SAIL, TISCO etc.) The contractor shall provide sufficient plant, equipments and labour as required by E/I and shall work for such hours and shifts as may be necessary to maintain the progress schedule. No extra payment shall be made for this.
- 3.5 Brick to be used in all brick work shall confirm to relevant ISI code specification.
- 3.6 The contractor shall make adequate arrangement for the safety of the labourers during execution of work and shall be guided by the prevailing Labour rules.
- 3.7 The contractor shall have to get tested the strength of cement concrete (both plain & reinforce) for each day's casting as per BIS codes. Achievement of the prescribed cube strength is a must. Concrete having lower value shall be rejected under specific order of the competent authority. The cost of concrete cube moulds curing, carriage of cubes to and from the testing laboratory and all other incidental charges incurred in this regard shall be borne by the contractor.
- 3.8 The contractor shall, if required by the E/I., arrange for testing of materials of a particular portion of work at his own cost to prove their quality, soundness and sufficiency. If the quality of materials appears to be inferior or the portion of work is found to be defective or unsound, the contractor may be asked to remove and/or dismantle and re-execute the same at his own cost. To do so will be mandatory for the contractor.
- 3.9 All rejected materials will have to be removed from site by the contractor after their rejection within three days for which E/I or site incharge should give order in writing. Otherwise E/I or site incharge may dispose them off in any way he thinks fit and also recover the cost from the contractor for such removal .
- 3.10 After completion of work the contractor will remove all debris, fill up vats etc. as per direction of E/I. and leave the site clean and tidy at his own cost.
- 3.11 DEO-CUM-DPO, JEP reserves the right of omitting and stopping the construction or to change design and specification at any stage etc, if considered necessary at subsequent stage.
- 3.12 The following shall not be paid extra and the tendered rates shall be inclusive of these :-
 - (i) Site clearance such as cleaning of shrubs, bush, wood under growth and small trees.
 - (ii) Setting out works, profile layout, taking levels etc.
 - (iii) Construction of temporary site office.

- (iv) Bailing out rain water/and or surface water in case the excavated foundation trenches are filled up by these during the period of construction.
 - (v) Making vats, platforms etc.
- 3.13 The contractor has to use his own machinery for completion of the work within the time stipulated in the contract. The carriage of machinery to different sites under this contracts from one place to another for the work will be responsibility of the contractor and all expenses in this regard will be borne by him.
- 3.14 Carriage and running charges of the machineries, if any, including any incidental and contingent charges, transporting the same from place of delivery to the work site and their return to the place of issue shall be borne by the contractor at his own cost.
- 3.15 The cost of fuel and lubricants for the running machinery will be borne by the contractor.
- 3.16 CLAIMS shall not be admissible under following circumstances:-
- (a) Extra items of works done without written order of E/I.
 - (b) In case of sudden fluctuation and/or increase in rates of labour, material, royalty, various taxes, railway freight, fuel, lubricants, carriage cost etc. at any stage of the work.
 - (c) Short supply and/or non-supply of materials and/or equipments.
 - (d) Non availability of labour of any categories required for the work.
 - (e) Delay due to changes or modification in design, drawing, specification, etc. at any stage or work.
 - (f) Loss sustained due to:-
 - (i) Acts of enemy including agitation by public riot.
 - (ii) Transportation and procurement difficulties.
 - (iii) Natural circumstances/calamities.
 - (iv) Any other circumstances which is beyond human control.
- 3.17 The successful Tenderer will have to make arrangement entirely at his own cost for water supply needed for the construction works.
- 3.18 Security money of contractor will be released after three months (Max Six Months) of satisfactory completion and handing over the work. Contractor will be fully responsible regarding the quality and specification of the work.
- 3.19 Defect liability period for the work will be six months from the handing over the building. And any defect found during the defect liability period will have to be rectified by the contractor at his own cost.
- 3.20 No mobilization advance/secured advance shall be paid to the contractor.
- 3.21 Necessary haul roads and roads to water sources connected with the work shall be maintained by the contractor at his own cost.
- 3.22 The various works shall be done true to line, level, and grade. The periodical checking of these by the supervising engineers shall not absolve the contractor of his responsibility regarding their accuracy. In case of any deviation or discrepancy in line, level or grade, the contractor shall have to rectify the same at his own cost and without any compensation for the additional work, if any involved.
- 3.23 The contractor shall be bound to execute any additional work deemed to be part and parcel of the agreed work beyond the agreement, under the specific order of the competent authority.

CHAPTER - IV
TECHNICAL QUALIFICATION INFORMATION

- 4.1 The tenderer will have to submit their duly audited financial turn over for the last three years preceding from the current financial year. Total turn over during these three financial years should not be less than 2 times of the estimated value of work including turnover of more than estimated value of work during any one year.
- 4.2 Tenderer will have to submit work experience of building construction work for the last three years. They are required to have completed building construction work amounting to at least 90% of estimated value of works during proceeding three years . (Payment certificate to be attached duly issued by competent authority not below the rank of Executive Engineer.)
- 4.3. Bidders who meet the minimum qualification criteria will be qualified only if their available bid capacity is more than the total bid value. The available bid capacity will be calculated as under:

Assessed Available Bid capacity = (A*N*2-B)

where

A = Maximum value of civil engineering works executed in any one year during the last three years taking into account the completed as well as works in progress.

N = Number of years prescribed for completion of the works for which bids are invited.

B = Value of existing commitments and on-going works to be completed during the next 12 months.

Note: The statements showing the value of existing commitments and on-going works as well as the stipulate period of completion remaining for each of the works listed should be countersigned by the engineer in charge, not below the rank of an Executive Engineer or equivalent.
